

## ODA Updates for SWCD Board Meetings November 2024

**Board Supervisor Survey** - A survey has been created to poll SWCD Board Supervisors to evaluate their training and on-boarding experience. <u>ADP – Administrative Development Program</u> - The next ADP session is scheduled for November 7<sup>th</sup> and will focus on risk management and coverage as well as annual plan of work development relating to state match policy. Attendees are requested to bring laptops, annual plans of work and strategic plans. These will all be utilized during the training.

<u>1099's – Have you ordered your forms -</u> It's nearly the end of the year and time to start preparing to complete the necessary 1099 forms for those that you issued payment to over \$600 in calendar year 2024. If you do not utilize the service of an accountant, and you have not yet ordered forms, please make sure to visit <u>https://apps.irs.gov/app/taxmat/information-employer-returns/</u>. Designate the proper form and number of forms needed. Make sure you order extra in case you happen to make a mistake. Do not forget to also order form 1096 which is required for submission of the 1099 forms to the IRS.

There are three primary types that you may need:

1). 1099-G These will need to be provided to all landowners that received payments for MWCD, H2Ohio, 299, or any other conservation related type of government payment issued by the Soil and Water Conservation District.

2). 1099-NEC Issued for non-employee compensation. This would be for services provided to your district by someone that is not an employee. For example: subcontractor, potentially a no till drill contract employee, caterer, and attorney fees.

3). 1099-Misc This should be used for payments such as rent and prizes/awards.

If you have additional questions reference the instruction publications found on the IRS website for each of these forms.

<u>New Staff</u> – We are excited to welcome **Alison Manning** to the division beginning November 4<sup>th</sup> in the role of Area 4 South Program Specialist. Her office will be located in Montgomery County, and she will be covering Butler, Clermont, Clinton, Fayette, Greene, Hamilton, Montgomery, Preble, and Warren counties. Alison comes to the division after previously serving as a Natural Resource Coordinator for the City of Middletown. DSWC also welcomes Darcy Griffin-Kamerer to our team. Darcy will help with central office support, managing day to day tasks of the Division, helping with tracking and record keeping and assisting with administrative duties.

**<u>APAP</u>** - The Division made some internal changes to the Agriculture Pollution Abatement Program. Jason Tyrell will be transferring to a field-based position located in Perry County. He is available for pollution complaint investigations, trainings, and Beehive help in areas 2, 3, and 5. Frances Springer will continue to provide similar APAP assistance in areas 1 and 4. Please continue to work with Program Specialists on APAP complaints but know that additional APAP assistance is available from Frances and Jason.

**Ohio Educator Workshop** - Fifty-four people attended the 3<sup>rd</sup> annual Ohio SWCD Educator's workshop on October 23<sup>rd</sup> and 24<sup>th</sup> at Sauder Village in Fulton County. Educators participated in a variety of workshops including fair booths, classroom education demonstrations, library programs and roundtable sharing of local programs. The 2025 Educator's Workshop will be moving to Area 2. Watch for the save the date next spring.

<u>Watershed Update -</u> The Ohio Department of Agriculture (ODA) is pleased to announce it has been selected to receive more than \$9 million in grant funding from the Natural Resources Conservation Service (NRCS) for ODA's H2Ohio Pasture-Hayland Regional Conservation Partnership Program project application. Funding will provide producers the opportunity to improve water quality through implementation of pasture and hayland conservation practices as a companion to statewide H2Ohio incentives. Project areas will include counties in southern and eastern Ohio.ODA looks forward to sharing more details as they become finalized in the coming months.

<u>Ag Assistance Grant</u> - In November we hope to move forward with the Agriculture Assistance Grant and send agreements to eligible SWCDs. The Ag Assistance Grant was developed to support smaller SWCDs and enable them to hire additional staff to increase technical assistance. This opportunity is jointly funded through NRCS and the OSWCC. OFSWCD and ODA will provide in-kind support, training, and assist with grant administration.

<u>Cover Crop Seed Testing</u> - NRCS practice standards require seed testing for any uncertified seed sources (bin run, producer harvest, or uncertified bulk seed sources). Seed must be tested by a reputable lab for germination, % noxious weed seeds, and purity. ODA Plant Health <u>does not</u> physically test cover crop seed. Samples submitted to ODA are sent to a private lab for testing. ODA Plant Health has provided this service free of charge. <u>Ohio Hay Directory</u> - Hay shortages and availability have been a common problem in many of Ohio's Drought impacted counties.
